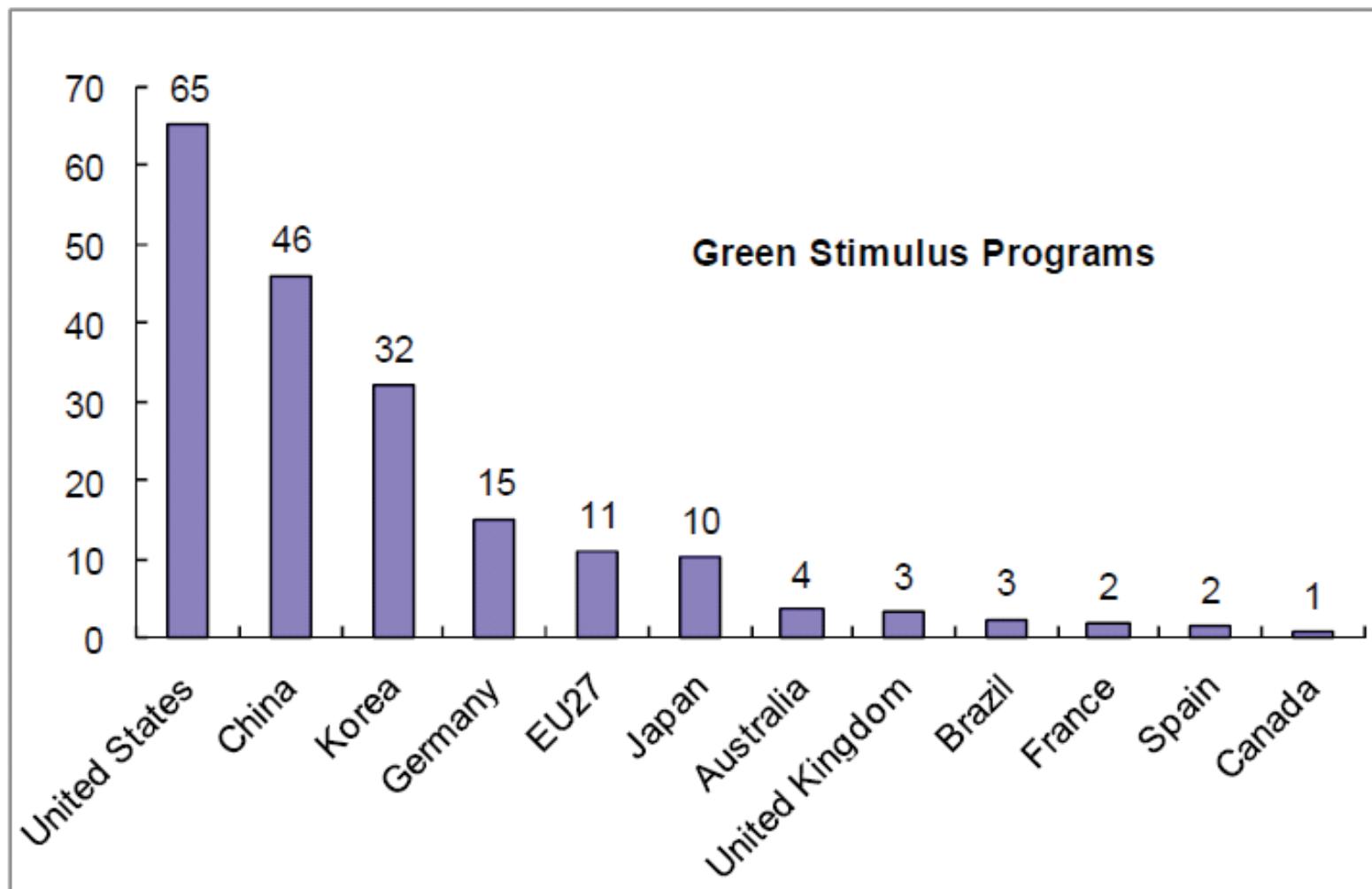


**Figure 4. Green Component of Economic Stimuli as of February 2010**

- Smanjenje CO<sub>2</sub> emisija 80-95% do 2050. godine







# Utjecaj sektorskih radionica
